Kancho Hirokazu Kanazawa founded Shotokan Karate-do International in 1977. Legendary in his art, Kancho Kanazawa, remains one of the premiere practitioners of Shotokan karate today. His karate regimen is based on discipline and focused attention of the basic techniques. Its result is physical and spiritual growth, power, grace and balance. Kancho Kanazawa is one of the last direct students of Master Gichin Funakoshi, the founder of Shotokan Karate-Do. Kancho Kanazawa has earned world-wide respect as one of the highest level and most popular karate practitioners. His rank is 10th Dan.

Sensei Nobuaki Kanazawa (6th Dan) is the son of Kancho Kanazawa and is an accomplished karateka. Sensei Nobuaki Kanazawa was the 2004 Japan National Champion, holding 6 JKF (Japan Karate-Do Federation) Championships and was SKI All Japan champion from 1996-2000.
